Any such contract entered by Integrated Wealth will include provisions designed to ensure that the third party will uphold and maintain privacy standards when handling personal information. Integrated Wealth discloses personal information to regulatory authorities as required by applicable law. | No |

What we do

How does Integrated Wealth protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, secured files and buildings, prompt disposal of all unnecessary customer information, limiting access to information about you to only those associates who have a need to know, and training our associates.

How does Integrated Wealth collect my personal information?

We collect your personal information, for example, when you:

- Complete account paperwork
- Seek advice about your investments
- Enter into an investment advisory contract
- Give us your contact information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only:

- Sharing for affiliates' everyday business purposes – information about your creditworthiness
- Affiliates from using your information to market to you
- Sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- ***Integrated Wealth does not share with our affiliates***

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- ***Integrated Wealth shares personal information described above for business purposes with non-affiliated third parties performing transaction processing or servicing on behalf of Integrated Wealth and otherwise as permitted by law. Such companies include our Broker-Dealer, Geneos Wealth Management, Inc. Member FINRA/SIPC and other broker-dealers, banks, investment advisers, mutual fund companies and insurance companies. Integrated Wealth shares personal information with parties who provide technical support for our hardware and software systems and our legal and accounting professionals. Integrated Wealth does not share with non-affiliates so that they can market their services or products to you.***

Joint Marketing

A formal agreement between nonaffiliates' financial companies that together market financial products to you.

- ***Integrated Wealth doesn't jointly market.***
